Bidders are required to follow the electronic bid submission procedures as specified in e-GP System operating Guidelines 2073 and user Manuals issued by PPMO which are available in e-GP system and its website.
5. The bids will be opened at 13:00, 2077-09-06 in the presence of Office representatives and Bidder's representatives, who choose to attend at the office of Khaniyabas rural Municipality. Bids must valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting, which shall be valid for 30 days beyond the bid validity period.
